Quick Summary for Players

Welcome to Lucky Vault Card! Please read this summary of our key rules:

- **One Account Per Player**: Creating multiple accounts is strictly forbidden.
- **Play Fair**: Cheating, using cheat software, or accessing another player's account will result in the immediate deletion of your account.
- **Season System**: Your account and progress are tied to a **60-day season**. At the end of the season, your account will be automatically reset to make way for a new season.

- **Ads for Rewards:** To earn UR (the game's virtual currency) by watching ads, you must not use an ad blocker. If you use an ad blocker, you will not receive UR.

1. Acceptance of Terms

Welcome to Lucky Vault Card (the "Game"), a digital card game provided by Arlondo Bloom (the "Company," "we," "us," or "our"). By accessing, downloading, or playing the Game, you ("the Player," "you," or "your") agree to be bound by these Terms of Use ("Terms"). If you do not agree to all of these Terms, you are not permitted to play the Game.

2. Player Account

2.1. Account Creation. You may be required to create an account to access all features of the Game. You agree to provide accurate and complete information during registration.

2.2. One Account Per Player. Each player is strictly permitted to create and maintain only one (1) user account. The creation of multiple accounts is expressly prohibited and may result in the termination of all associated accounts.

2.3. Account Security. You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account.

3. Code of Conduct and Prohibited Actions

You agree not to engage in any of the following prohibited activities. Violation of these rules will result in the **immediate deletion of your account** without prior notice:

- **Cheating:** Using any exploit, bug, or flaw in the Game to gain an unfair advantage.
- **Cheat Software:** Using any unauthorized third-party software, scripts, bots, or mods designed to modify the Game client or automate gameplay.
- **Account Intrusion:** Accessing or attempting to access another player's account.
- **Disruption:** Any action that disrupts or interferes with the Game, its servers, or the experience of other players.

4. Game Season and Account Reset

4.1. Seasonal System. The Player acknowledges and agrees that the Game operates on a seasonal system. Each season has a duration of sixty (60) days.

4.2. Automatic Account Reset. At the end of each season, your player account, including all progress, cards, and in-game items, will be **automatically and permanently reset or deleted** to allow for the start of a new season. No data from the previous season will be carried over unless explicitly stated otherwise by the Company.

5. Virtual Currency and Advertising

5.1. Virtual Currency. The Game features a virtual currency called "UR" which can be earned through gameplay or by watching video advertisements.

5.2. Ad Blocker Restriction. The Player acknowledges and agrees that if they use an ad blocker or any other technology that prevents the display of advertisements, they **will not be eligible to receive UR** from the advertisement-watching feature. The Company is not responsible for the failure to deliver UR if an ad blocker is active on the Player's device.

6. Intellectual Property

All rights, title, and interest in and to the Game (including, but not limited to, all artwork, graphics, card designs, software, and code) are the exclusive property of Arlondo Bloom and its licensors.

7. Termination

We reserve the right to suspend or terminate your access to the Game at any time, for any reason, including but not limited to, a violation of these Terms.

8. Limitation of Liability

To the fullest extent permitted by law, Arlondo Bloom shall not be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or relating to your use of the Game.
